Rationale:

Black Hill Primary School is committed to providing a safe, secure and caring learning environment for all its students. The internet and digital technologies provide many opportunities for student engagement and learning. While the use of digital technology is an exciting learning tool, it is important for students to be responsible and safe when working in the online environment or using technology. Students must be cyber-ready and cyber-safe, to prevent exposure to cyberbullying or unacceptable behaviour that may occur.

Aims:

For Black Hill Primary School to develop a whole school approach to ensure its students access appropriate content and are protected from bullying and cyberbullying while at school.

The eSmart Policy should be read in conjunction with the following policy documents:

- DT Acceptable Use Policy
- Student Wellbeing Policy
- Internet and Network Usage Policy

Implementation:

- All staff members are to be familiar with the above policy documents. Staff are to familiarise themselves at the beginning of each school year with each policy document and carry out the necessary requirements within their classroom and as part of their daily duties while at school.
- At the beginning of each school year, and at any other time as needed, teachers are to familiarise the students with the protocols in place for using digital technologies, including both the safe handling of equipment together with the penalties imposed if incorrect use occurs.
- Throughout each school year, students will receive explicit education of an eSmart curriculum in relation to:
 - Staying safe online.
 - How to deal with conflict, bullying, cyber-bullying and harassment.
 - Building confidence, resilience, persistence, getting along and organisational skills.
- The staff at Black Hill Primary School will use the following resources to enhance their teaching of an eSmart curriculum:
 - Kids Matter

- Bullystoppers
- Budd-e Program
- Guest Speakers

- Black Hill Primary School is committed to educating not only its students but also its wider community. As such, information relating to the eSmart Curriculum will be produced and distributed through school newsletters and the school website. Information sessions, which may include guest speakers, will be made available to the wider school community at times and will be advertised through the normal channels of communications.
- Parents and students must sign a DT Acceptable Use Agreement annually.
- All teachers must go over the DT Acceptable Use Agreement with their class at the commencement of Term One each year.
- An enlarged copy of the DT Acceptable Use Agreement must be displayed in every classroom alongside the Breaking the DT Acceptable Use Agreement
- All staff members are responsible for ensuring that students adhere to the DT Acceptable Use Agreement. Any breaches of this agreement will be documented on a shared file on the staff drive and appropriate consequences as set out in the Breaking the DT Agreement document will be given.
- The use of computers is a part of everyday learning whilst at Black Hill Primary School. Students are expected to adhere to the BYOD Agreement and the Internet and Network Usage Policy while using these devices at school.
- All students and staff are responsible for reporting any form of bullying (including cyber-bullying) or harassment to either a teacher or the Principal/Assistant Principals, and to also record details on Compass.
- The school community as a whole has a responsibility for the safety of the students at Black Hill Primary School, and as such, parents and caregivers and others who witness any form of conflict, bullying (including cyber-bullying) or harassment are expected to report this to the Principal/Assistant Principals as soon as is practicable.
